What does the WAGES Weatherization Program do?

- Educates clients in safety and energy efficiency
- Professionally evaluates single family dwellings (houses and mobile homes) for safety and energy efficiency
- Tunes, repairs or replaces heating and air systems as needed
- Insulates attics, floors and walls as needed
- Makes minor repairs to homes for health and safety reasons
- Installs smoke and carbon monoxide detectors
- Performs base load and general heat waste measures like:
 - Install compact fluorescent lights, wrap water heater, pipe insulation, low flow shower heads, and furnace filters
- · Insulate attic, walls, and floors
- Install ventilation such as bathroom vent fan



What do home inspections include?

- Test for gas leaks, carbon monoxide, and other health and safety issues
- Check combustion appliances such as stoves, furnaces, and water heaters
- Check for air infiltration / drafts
- Check for attic, wall and floor insulation
- Check for leaky ducts and proper ventilation







THE WAGES WEATHERIZATION PROGRAM IS NOT A HOME REHABILITATION PROGRAM. WE DO NOT:

- Make major home repairs such as new roofs, new floors, plumbing, electrical work
- Build additions
- Paint (other than areas disturbed by weatherization work)
- Lay carpet
- Remove lead based paint, asbestos or mold

- 1) <u>PROOF OF OWNERSHIP</u> copy of property tax statement OR copy of deed or title, OR <u>for</u> <u>mobile home a personal property tax statement is required</u>. (The address must be the same on this documentation as the address of the unit to be weatherized).
- 2) <u>PICTURE ID OF APPLICANT</u> Identification card or driver's license. (Must be a valid North Carolina Driver's License or ID) and Social Security numbers for all household members.
- 3) <u>INCOME VERIFICATION for past 12 months</u> of all persons over 18 years of age living in the household pay stubs (if paid: weekly we need last six paystubs, bi-weekly last three paystubs, monthly last two paystubs) or tax information (W-2(s) or 1099(s)), retirement/pension benefit statements, Social Security award letter, Supplemental Security Income award letter, Disability award letter, Unemployment benefits, Adoption Assistance, etc.

 If NO income for prior 12 months, a notarized No Income Client Statement is required.
- 4) <u>ELECTRIC AND / OR GAS / PROPANE BILLS (LP) / OIL / KEROSENE</u> 24 Month Billing and Usage History

 A 24 month <u>BILLING & USAGE History</u> of above utilities must be received prior to completing your application. Please provide Utility Company and account numbers.
