RESOLUTION **REQUIRING THE REGISTER OF DEEDS OF GREENE COUNTY** NOT TO ACCEPT DEEDS TRANSFERRING REAL PROPERTY FOR REGISTRATION WHERE PROPERTY IS SUBJECT TO DELINOUENT TAXES

WHEREAS, N.C.G.S. 161-31 authorizes the Board of Commissioners of certain specifically-identified counties to adopt a resolution requiring the Register of Deeds of that county not to accept any deed transferring real property for registration unless (1) the tax collector for that county has certified that no delinguent ad valorem taxes, or other taxes with which the collector is charged with collecting, are a lien of the property described in the deed, or (2) the deed contains a statement from a licensed North Carolina attorney confirming that such delinguent taxes, if any, shall be paid by the closing attorney to the county tax collector upon disbursement of closing proceeds; and

WHEREAS, it is in the best interest of the citizens of Greene County that delinquent taxes are collected on real property prior to the transfer of such real property.

NOW, THEREFORE BE IT RESOLVED, that pursuant to N.C.G.S. 161-31, the Register of Deeds of Greene County shall not accept any deed transferring real property for registration unless the Greene County Tax Collector has certified that no delinguent ad valorem county taxes, ad valorem municipal taxes, or other taxes with which the collector is charged are a lien on the property described in the deed;

BE IT FURTHER RESOLVED, that the Register of Deeds of Greene County shall accept without certification from the county tax collector a deed submitted for registration under the supervision of a closing attorney and containing this statement on the deed: "This instrument prepared by:_____ , a licensed North Carolina attorney. Delinquent taxes, if any, to be paid by the closing attorney to the county tax collector upon disbursement of closing proceeds.".

BE IT FURTHER RESOLVED, that the Tax Administrator is authorized to develop such forms, stamps, policies, and other administrative mechanisms as are necessary and otherwise consistent with law to carry out the intent of this Resolution; and

BE IT FURTHER RESOLVED, that this Resolution shall apply to all deeds submitted for registration after December 31, 2007.
